Section I: Introduction and Background

1.1 Purpose of RFP

The Event and Entertainment Management Association (EEMA) invites proposals from qualified and experienced **website development agencies based in Delhi/NCR** to design, develop, upgrade, and maintain the official EEMA website.

The objective is to build a seamless, modern, fast, and scalable digital platform reflecting EEMA's stature as the apex body of India's experiential industry.

1.2 EEMA Overview

Established in 2008, EEMA is India's only national body representing the event and experiential marketing industry, bringing together leading agencies across events, MICE, activations, entertainment, sports, and weddings—representing nearly 80% of the organised sector.

The scope includes full-cycle website design, development, testing, deployment, and maintenance.

- User journey mapping for members, partners, and visitors
- Mobile-first responsive design
- Accessibility compliance (WCAG)

B. Development & Backend

- Member login/dashboard with profile management
- Online membership registration form linked to payment gateway
- Integration of CRM / Google Workspace / Email workflows
- Committee pages with updates
- News, announcements & resource library
- Search functionality
- Multilevel admin access

- Automated archive for past events
- Media coverage section

4.3 Evaluation Criteria

Criteria	Weightage
UI/UX & Proposed Website Strategy	40%
Relevant Experience & Portfolio	30%
Team Capability & Technical Expertise	20%
Financial Proposal	10%

Agencies may be invited for a virtual or in-person presentation.

- The selected agency shall enter into a Service Agreement.
- All assets and source code will remain EEMA's property.
