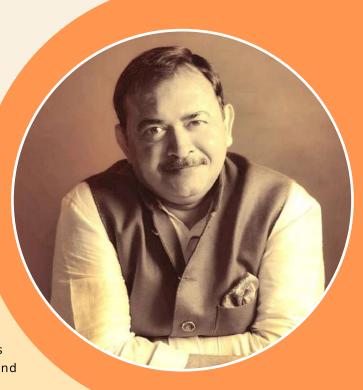

Ms. Mugdha Sinha gave a patient hearing and assured the gathering that she would try to resolve the existing problems by getting other stakeholders on the table.

Mathadi Extortion in the Event Industry

EEMA is taking significant steps to combat the issue of Mathadi extortion, which has been affecting the event management industry in Mumbai. In a recent productive meeting with DCP Datta Kamble (Zone 3), EEMA made substantial progress in addressing this challenge. The police assured EEMA that they would take a firm stand against illegal Mathadi demands, with a dedicated point of contact established for complaints. Additionally, discussions are underway to streamline the NOC processes for events, ensuring smoother operations in the future.

EEMA remains committed to resolving these industry challenges and is planning further meetings with DCPs across key event zones to strengthen collaboration. This unified action, under the guidance of the Joint Commissioner of Police, aims to create a hassle-free environment for event organizers. EEMA urges its members to report any incidents, reinforcing our collective efforts to safeguard the event industry from unfair practices.

The report titled "Shape the Future: Indian Media and Entertainment is Scripting a New Story" by EY highlights several key developments in India's Media and Entertainment (M&E) sector:

- **Digital Media Surpasses Television:** In 2024, digital media overtook television to become the largest segment of the Indian M&E industry, contributing 32% of the total revenues.
- Overall Industry Growth: The M&E sector grew by 3.3% in 2024, reaching INR2.5 trillion (US\$29.4 billion).
- **Projected Expansion:** The industry is expected to grow by 7.2% in 2025, reaching INR2.68 trillion (US\$31.6 billion), and is projected to further expand to INR3.07 trillion by 2027.
- **Transformation in Content Dynamics:** The shift towards digital has redefined content creation, distribution, and monetization, emphasizing information, escapism, materialism, and self-actualization

These insights underscore the rapid evolution of India's M&E sector, highlighting the growing dominance of digital platforms and the industry's robust growth trajectory.

Neha Kakkar Melbourne Concert: Challenges & Learnings

Challenges

The concert experienced unexpected delays, leading to a long wait for attendees. Limited real-time communication from the organizers caused confusion among the audience. As a result, some attendees expressed their concerns on social media, while others requested refunds. The situation highlighted the importance of efficient event management and proactive crisis handling to ensure a smooth experience for both the artist and the audience.

Solutions

- **Better Artist & Organizer Coordination:** Establish strict arrival schedules with buffer time and use real-time tracking for artist logistics.
- Transparent Communication: Provide live updates through event apps, social media, and venue announcements to keep attendees informed.
- **Efficient Backup Planning:** Prepare secondary performances or pre-recorded content to engage the audience in case of unexpected delays.
- Clear Ticketing & Refund Policies: Offer partial refunds, discounts for future events, or VIP experiences as goodwill compensation for major disruptions.
- **Crisis Management Strategy:** Train staff to handle audience concerns professionally and issue immediate public statements from both the artist and organizers to maintain credibility.
